C.A.R.E (A Cost Sharing Funeral Service)

Membership Rules:

- 1. CARE membership is open for all CANADIAN Residence.
- 2. A membership includes a family household. The Family Household members are defined as spouse and dependent children up to 25 years of age.
- 3. If a dependent family member gets married before the age of 25, then he/she need to register as a separate member to avail the benefits of the CARE services.
- 4. Parents of a member should be registered separately to avail the benefits of the CARE services.
- 5. One-time membership registration fee is \$150.00.
- 6. Members are required to promptly inform CARE of any change in their banking information.
- 7. If a member decided to withdraw from the group, there will be no refund to the member for his/her contribution to the group. Member shall give at least two (2) months to close his/her membership and return his/her membership card.
- 8. Family to be paid \$5,000.00 to cover their funeral cost.
- 9. Committee will present the financial statement once a year to all the members during the Annual General Meeting (AGM)



Compassionate And Respectful Ending

CARE Service, Islamic Funeral Funding Group

Objectives:

Create a member-based group to provide affordable Islamic funeral services to the Canadian Muslim community. The members in the organization will:

- 1. pay a one-time registration fee, and
- 2. share the total funeral cost of a fellow member equally in order to avoid financial difficulty during a loss of a family member.

About Us:

In the spirit of brotherhood and uniting the Muslim community, CARE - Compassionate And Respectful Ending Services was established in May 2017 to provide a membership based group to fund Islamic funerals.

The Prophet strongly encouraged brotherhood amongst the Muslims as Ibn `Umar (May Allah be pleased with them) reported: The Messenger of Allah said:

"A Muslim is a brother of (another) Muslim, he neither wrongs him nor does hand him over to one who does him wrong. If anyone fulfils his brother's needs, Allah will fulfil his needs; if one relieves a Muslim of his troubles, Allah will relieve his troubles on the Day of Resurrection..." [Bukhari and Muslim].

The Islamic funeral fund membership is open to all Muslim families in Canada. Members are required to pay a one-time registration fee which includes services for dependent family members residing at the same address.

The Prophet also encouraged us to frequently remember our upcoming death as Abu Huraira reported that the Messenger of Allah said,

"Remember frequently the thing that cuts off pleasures," i.e. death." [at-Tirmidhi]

MUSLIMCARE MEMBERSHIP TERMS & CONDITIONS

Last updated: November 24, 2019

Membership Eligibility

- Must be of legal age to register
- Dependents include unmarried children living at the same address as member
- ➤ Any of the children of the family member turning over the age of 25 years need a separate membership registration
- Parents living at the same address must complete separate membership registration

Membership Requirements

- Membership must be in good standing for claim payments
- ➤ Member is responsible for NSF charges if banking information update was not provided at least 30 days prior to charges
- Members will be issued warning if any occurrence/incidence of NSF.
- After missing TWO consecutive payments, the membership will be suspended until all the outstanding payment(s) are cleared.

Claim Payments

- Claim payments will be \$5000CAD
- Claim payments only valid for funeral services in Canada and United States of America
- Claim payments outside of Canada and United States of America may be requested to be reviewed by the CARE committee

➤ Membership should ALWAYS have to be in good standing to be eligible to receive the claim payment.

Acceptable Support Documents

- Completed claim form (Enclosed)
- Evidence of death Any of the following:
 - a. Death certificate
 - b. Coroner's report
 - c. Medical certificate of Cause of Death

Claims Processing

- Submit claim form with legal supporting documents.
- Processing claim is subject to compliance to the terms and conditions of membership and further inquiry by CARE Committee.
- Incomplete claim forms and/or claims without all supporting documents will not be processed.

Administration

- CARE will operate as a not-for-profit organization.
- CARE will respect the member contributions by maintaining minimal operational and administrational costs.
- ➤ CARE committee members will operate the organization as volunteers.
- > CARE will hold an Annual General Meeting (AGM) to present Financial Statement and updated progress of the program.
